**1. CALL MEETING TO ORDER/WELCOME**

A quorum of members was present to call the meeting to order at 10:13 A.M. **2. APPOINTMENT**

Lauri Dodd offered some suggestions for PR and the group discussed reaching out to the school district for possible inclusion (however the work is slated to begin during the district's Spring Break).

Commission members reviewed meeting minutes and a motion was made by Kathleen Morrow to accept the minutes as presented. Chairman Sweet seconded the motion and it passed unanimously 5-0.

**B. Discussion and possible action related to mural project located on eastern facing wall of 109 E. Kaufman Street.**

Commissioner's discussed different concepts for the wall, emphasizing their desire to gear the design towards cars. The current sign on the wall and former use of the property was a used car facility. Commissioner's suggested asking Isaac for his ideas/concepts for the wall.

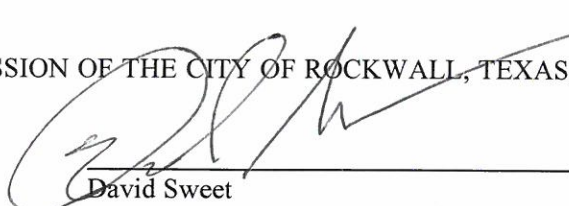
**C. Discuss future mural locations and art projects for the downtown area.**

#### **1. CALL MEETING TO ORDER/WELCOME**

A quorum of members was present to call the meeting to order at 8:30 A.M. Present were Commission Chair, David Sweet and commission members: Kathleen Morrow, Betty Jean Hoaglund, Jane Braddock and Doug Agee. Also present, City of Rockwall Community Relations Manager, Bethany Browning, Guests, Kevin Lefere and Al Lefere, Zanata.

#### **2. APPOINTMENT**

##### **A. Appointment with Kevin Lefere and Al Lefere to discuss a possible mural project.**

Commission members reviewed meeting minutes and a motion was made by Kathleen Morrow to accept the minutes as presented. Betty Hoaglund seconded the motion and it passed unanimously 5-0.

##### **B. Discussion and possible action related to future art projects.**

Commissioner's discussed concepts for the proposed mural at 109 E. Kaufman Street. Commissioner's asked the staff liaison to communicate their ideas with Isaac Davies and ask that he provide the group with some design concepts. Elements for consideration included the following: 50's era cars and structures, Bankhead Highway signs and the inclusion of the sign that is currently located on the wall that reads Ted Cain's Used Autos.

#### **4. UPDATES**

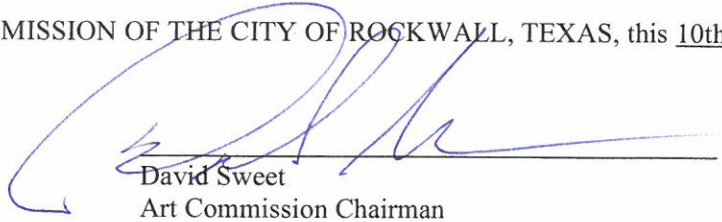
##### **A. Update on the upcoming mural installation at 110 S. Goliad, slated to begin March 13, 2017.**

### 1. CALL MEETING TO ORDER/WELCOME

Kaufman Street and asked Browning to obtain conceptual ideas as soon as possible.

#### C. Discussion and possible action regarding the mural project at 202 E. Rusk.

Commissioner's discussed the Zanata site and the possibility of doing an open call for artist for that project. A timeline has not been set for that project, as the commission is focusing their efforts on finishing the current mural at 110 S. Goliad and installation of the next mural at 109 E. Kaufman.

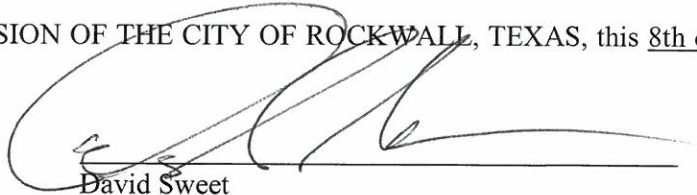
#### D. Discussion and possible action related to future downtown art installations.

#### **1. CALL MEETING TO ORDER/WELCOME**

A quorum of members was present to call the meeting to order at 10:04 A.M. Present were Commission Chair, David Sweet and commission members: Kathleen Morrow, Betty Jean Hoaglund and Doug Agee and City of Rockwall Community Relations Manager, Bethany Browning. Kristi Kennimer and Kara Fox, representatives from Scarlet Reagan Creative Studio were also present.

#### **2. APPOINTMENT**

##### **A. Appointment with representatives from Scarlet Reagan Creative Studio, to hear information about their studio and services offered.**

David Sweet opened the meeting and stated he had requested Scarlet Reagan CS be placed on the agenda as an appointment item. Scarlet Reagan CS contacted Mr. Sweet regarding their interest in the downtown mural projects. Kristi Kennimer and Kara Fox introduced themselves and gave the group an overview of their company. Kristi provided a packet of information to each commissioner and also provided details of the murals included, as well as her vision for downtown public art. She stressed that Rockwall was her hometown and that she had a special interest in providing quality murals that represent the community. Mural options were presented for the following locations: 202 E. Rusk, 213 E. Rusk, 101 S. Goliad and 109 E. Kaufman. Ms. Kennimer stated that she had actually met with the owner of 202 E. Rusk and presented her designs and that he liked one of the concepts presented (floral abstract, botanical style). As part of the presentation, Ms. Kennimer shared her proposal to paint three murals.

#### **3. DISCUSSION/ACTION ITEMS**

##### **A. Review and take action on minutes from the April 10, 2017 Art Commission meeting.**

Commission members reviewed meeting minutes and a motion was made by Doug Agee to accept the minutes as presented. Betty Hoaglund seconded the motion and it passed unanimously 4-0.

##### **B. Discussion and possible action related to design concepts for the 109 E. Kaufman Street mural.**

Commissioner's revisited the mural designs presented by Scarlet Reagan CS as well as concepts from Isaac Davies. Commissioner's discussed both options at length and concurred they'd prefer an open call process opposed to a direct call process. Some commissioner's expressed a concern it might be too much abstract artwork for the district and perhaps one abstract mural might be more appropriate. They also expressed some concern with the cost and remaining budget. Commissioners asked Ms. Browning to put together a template for the open call and suggested the group meet again to finalize the details of the document prior to publicizing it. Such details will include the budget, time frame for completion, theme and any other details relevant to the project.

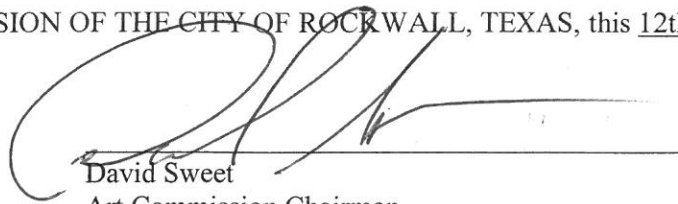
##### **C. Discussion and possible action related to future downtown art installations.**

Kathleen Morrow discussed the Discovery statue and the possibility of the Art Commission allocating funds toward the completion of the statue. She stated there was an active committee working on this project and the final costs is estimated at around \$200,000.00. Commissioners agreed to discuss this project further once additional details were presented. Kathleen stated they have a trip planned to a foundry in Oklahoma and that she would report findings back to the group upon return.

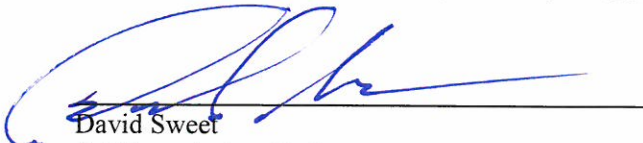
##### **C. Discussion and possible action related to future downtown art installations.**

There was no discussion related to future public art installations.

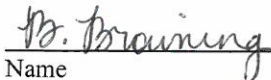

#### **1. CALL MEETING TO ORDER/WELCOME**

#### **2. APPOINTMENTS**

Ms. Browning asked about wall prep and Mr. Colcer asked that the wall be sealed properly at the top and that simple patchwork repairs be completed. He stated he could do the patchwork, but flashing and water infiltration issues be addressed by a roofing professional. Ms. Browning thanked Mr. Colcer for his time and stated she would be in touch regarding additional designs. Doug Agee made a motion to move forward with Mr. Colcer and Betty Hoaglund seconded the motion. Ms. Browning will begin addressing concerns related to the condition of the wall and commissioners agreed to work on design concepts.

#### **3. DISCUSSION/ACTION ITEMS**

##### **A. Review and take action on minutes from the August 7, 2017 Art Commission meeting.**

Due to attendance, commission members tabled this item until the next meeting.

##### **B. Review and discuss timeline for completion of 109 E. Kaufman Mural Project.**

Commissioners discussed an October deadline for installation of the mural. Commissioners agreed to reconvene prior to the regularly scheduled September meeting if needed. The consensus of the group was to move forward with estimates for assessment and prepping of the wall and new design from Mr. Colcer.

#### 1. CALL MEETING TO ORDER/WELCOME

##### D. Discussion and possible action related to the 202 E. Rusk Mural Project.

#### 1. CALL MEETING TO ORDER/WELCOME

A quorum of members was present to call the meeting to order at 9:00 A.M. Present were Commission Members: Betty Jean Hoaglund, Doug Agee, Kathleen Morrow and Jane Braddock. Also present, City of Rockwall Community Relations Manager Bethany Browning.

#### 2. DISCUSSION/ACTION ITEMS

##### A. Review and take action on minutes from the September 11, 2017 Art Commission meeting.

Commission members reviewed meeting minutes and a motion was made by Doug Agee to accept the minutes as presented. Betty Hoaglund seconded the motion and it passed unanimously 4-0.

##### B. Discussion and possible action related to the 109 E. Kaufman Mural Project.

Commissioners discussed the condition of the proposed mural site. Considerable repair is needed due to water damage between the masonry and the plaster causing the plaster to flake away exposing the brick façade, which is also crumbling. Commissioners discussed the costs and agreed they'd like to postpone the project. Jane made the motion to postpone a mural at this location and Betty seconded the motion. Motion passed 4-0 with no further discussion.

##### C. Discussion and possible action related to the 202 E. Rusk Mural Project.

Kathleen Morrow stated she had spoken with property owner Kevin Lefere regarding the desired artwork for the wall. His preference is historical in nature, associated with the original or most known use of the property, which is a drug store. Over the years, this property has been home to numerous drug stores, The Corner Drug, The Bailey Drug and Rockwall Drug. He did not express an interest in the selection of a muralist and was open to the City of Rockwall inspecting the wall. Commissioners discussed the following elements for inclusion in the design: Bonnie & Clyde, interior and exterior shots of the drug store and bright color palette versus sepia finish. No formal action was taken at this time. Commissioner's asked Ms. Browning to discuss the artwork with Mr. Colcer and to report back regarding the condition of the wall.

##### D. Discussion regarding future downtown art projects.

Kathleen Morrow shared additional information related to the Discovery Statue and asked that it be placed on the November agenda as an appointment with Mr. Lorne Liechty. Commissioner's had questions regarding project costs, location and timelines. Ms. Morrow stated she would talk with Mr. Liechty in an effort to prepare further detail in anticipation of the November meeting. Doug Agee asked about other projects for the downtown district such as metal artwork, with Betty Hoaglund also mentioning sidewalk art. Mr. Agee also asked that a sub-committee be formed to inspect quality/condition of artwork on at least a quarterly basis.
